

Emerald Society of Columbus General Membership Meeting Minutes Tuesday January 21, 2025

Meeting Called to Order: President Sean Moore called the meeting to order a 7pm and led us in the Pledge to the Flag.

Approval of the December Meeting Minutes: Secretary Mike Redmond: A motion to wave the reading and approve the December Meeting Minutes was made by Gary Rundio and seconded by Mike Mobley. Motion Carried.

Treasurer Report: Treasurer Mike Redmond reported that we have a total of \$16,124.34 in the bank account. We have \$7,079.15 in the Checking Account and \$9,045.18 in the Scholarship Account. We had expenses so far in January of \$1,565.25 and income of 41,559.34. A motion to accept the Treasurer Report was made by Carolina Castro and seconded by Dan Mentel. Motion Carried.

Membership Report: Secretary Mike Redmond reported that we have a total of 85 Members, that include 8 Associate Members. We have 28 New Members that includes 3 New Associate Members. We still have 29 Members from 2024 who have not renewed their Membership yet. President Sean Moore then reviewed the new applications with the membership. A motion to accept the new members was made by Seymour Ludwig and seconded by Randy Kinzel. Members Approved.

Clann na nGael Banquet: President Sean Moore reported that we have sponsored a table of 8 for the Clann na nGael Banquet on Saturday February 8th. We still have seats available so let him know if you want to attend. The cost of dinner this year is \$80 pp. A motion to pay for any Emerald Society Members dinner was made by Seymour Ludwig and seconded by Sean O'Reilly. Motion Carried. Any guest will have to pay for their dinner by reimbursement to the Emerald Society as we have already paid for the table.

Proclamation Day Charity: President Sean Moore advised that he has started attending the Clann na nGael Committee Meetings and that part of the Proclamation Day Activity on March 7th, each organization donates \$500 to a local charity. There was discussion about donating to a 501C3 Charity or if we could donate to an individual in the Law Enforcement of Fire Community in need of financial help. CPD Officer Blake Andrews was shot multiple times last year by as suspect who was later killed by responding officers. However, Officers Andrews was severally wounded and will never work again and in need of financial assistance. A motion to make our Proclamation Day donation to Officer Blake Andrews was made by Gary Rundio and seconded by Seymour Ludwig. Motion Carried.

Lenten Fish Frys: Our Lenten fish fry will start this year on Friday March 7th. We will need a few people on Thursdays to help prep the fish and other items. We will need additional people of Friday to help cook, serve and take admission payment. Cost this year will be \$17 Adult and \$12 Children.

Green Season Events: Green Season Events this year will be listed on our website as well as the Shamrock Club and most of the other Clann na nGael Organizations.
