General Membership Meeting Minutes

Meeting Called to Order: President Sean Moore called the General Membership meeting to order a 7:02pm and led us in the Pledge to the Flag.

Approval of the March Meeting Minutes: Secretary Mike Redmond: A motion to wave the reading and approve the April Meeting Minutes was made by Mike Molloy and seconded by John Collins. Motion Carried.

Treasurer Report: Treasurer Mike Redmond reported that we have a total of \$20,108.26 in the bank account. We have \$11,062.78 in the Checking Account and \$9,045.48 in the Scholarship Account. We still have 19 Members from 2024 who have not renewed their Membership yet. President Sean Moore then reviewed the 2 new applications with the membership.
